

HOW TO SUBMIT: ABSTRACT SUBMISSION

For Abstract Submission: Submission should be made online at https://forms.gle/cWZLfyB63Lj4ogrm8

All authors are asked to submit both:

Abstract Submission: Authors must submit the paper title, author names, contact details, and a brief abstract of up to 250 words electronically through the Fintech for Inclusion Summit 2024 paper submission site by the abstract submission deadline. Minor edits to the title and abstract are allowed until the full paper submission deadline. However, submissions with incomplete or placeholder abstracts may be rejected without review.

Extended abstract or full paper: Full papers must be submitted through the same site by the paper submission deadline. The list of author names provided

The deadline is final; authors cannot be added or removed after submission. (The order of authors can still be changed during the camera-ready period.) All authors must complete the author information form. This information is crucial for proper documentation and communication.

Note the details:

- a short (250 word) abstract; and
- either an extended abstract (2-4 pages, including tables) or a completed paper of not more than 25 pages including references (required to be considered for journal publication) to be uploaded

Submission Status

Upon submission of your paper for consideration, you will receive an email confirming receipt. Following the review process, if your paper is accepted for presentation at the conference, a notification email will be sent to your registered email address

Presentation Formats

Oral Presentation (15 minutes): Presenters will verbally deliver their research, typically accompanied by a PowerPoint slideshow, in standard presentation sessions organized by thematic streams.



Live-Stream Presentation (15 minutes): Scholars have the option to present online via Zoom, engaging with an international audience without the need for travel. This format offers the same benefits as in-person presentations, including Q&A sessions, publication in the Conference Proceedings, and participation in global discussions.

Panel Presentations (15 Minutes): Organized by individuals, panel discussions feature interactive discussions on specific topics. Speakers will contribute to the dialogue, with each session lasting *1 hour* and typically including introductions, short presentations by panel members, and open discussions.

Review

All papers will be blind peer-reviewed by the organizing institution. Only original, quality work will be accepted for presentation. A distinguished panel will assess the papers presented and award a prize to a young author whose work is deemed the best conference paper. The winner will be announced at the closing ceremony.

Conference Proceedings

Up to 20 top papers will be considered for submission for **regular publication** in the **American Journal of Finance and Accounting (ABDC Listed Journal)**. Follow these steps:

- **Register for the conference:** Registration is a prerequisite for publication consideration.
- **Upload your full paper** by **September 15, 2024**: Submit your paper through the online conference system.
- Format your paper correctly: Ensure your paper adheres to the Final Paper Guidelines available at https://www.inderscience.com/mobile/inauthors/index.php?pid=70. Only Microsoft Word and PDF format is accepted.

Benefits of Publication

- Gain recognition and wider reach for your research.
- Contribute to the advancement of knowledge in Fintech for Inclusion.
- Publish in a respected ABDC-listed Journal.

All accepted papers by the Journal will be published online in PDF format with a DOI (Digital Object Identifier) and ISSN (International Standard Serial Number).
